## Terms & Conditions

**Prices:** All prices shown in Canadian Dollars.

**Payments in Non-Canadian Funds:** US Cheques or transfers are accepted towards event payments; the conversion rate will be determined by SOMC's bank upon deposit.

**Facility Hours:** Spring/Fall facility access is from 8:00am to 6:00pm. Summer facility hours during June – August are 7:00am – 5:00pm. Seasonal track times may vary and are subject to change to accommodate weather conditions outside seasonal norms.

**Drop-Off / Pick-Up:** Drop off and pick up is on members lapping days. SOMC does not permit drop-offs or pick-ups outside operating hours without prior arrangement of extended hours. Extended hours fees may apply. Additional extended hours will apply automatically without notice if the member arrives outside of arranged accessible hours or stays for an extended period.

**Track Rules:** SOMC track policies and rules apply at all times.

**Storage Security:** The Member understands and consents to all stored items being kept in Area 27's paddock, in a locked and gated facility.

**Overnight:** Overnight use or access to the facility is not permitted. Anyone caught in violation will be subject to removal from security personnel and may incur a penalty subject to but notwithstanding being banned from the facility. Camping is not permitted on Area 27 property.

**Liability:** SOMC is not responsible for any items stolen or damaged to vehicles while stored on Area 27 premises.

**Amendments:** The provisions of this agreement may be modified subject to the terms and conditions herein by either party. No such modification shall be deemed effective unless in writing and signed.

**Counterparts:** This agreement may be executed in two (2) or more counterparts, all of which taken together shall constitute one agreement.

## Cancellation Terms

Under the terms of this agreement, SOMC is reserving storage space described herein for the Member. Notwithstanding any other provisions of this agreement, the Member shall have the right to cancel this agreement, without cause, upon written notice to SOMC at any time prior to the event. At no time following the execution of this agreement will the deposit become refundable, transferrable, or deposit obligation be broken.

The performance of this Agreement is subject to acts of God and force majeure that make it impossible to perform the obligations under this Agreement. The group shall have no right to cancel for any weather-related reasons.

## Acceptance

This agreement shall be deemed accepted only when an authorized Member has signed it. SOMC will then countersign this agreement and a copy will be kept on file. At that time, the booking shall be considered definite and shall be binding with a full deposit due. All changes, additions, deletions, or modifications must be initialed or otherwise approved in writing by both parties. Acceptance must be received by scanned email and this agreement may be executed in one or more counterparts shall be deemed to be an original, and all of which shall be deemed to be the same agreement. By signing this agreement, the organiser agrees to the terms of the agreement as stated above.
